COACH LISTINGS ON WEBSITE: USA-S General Counsel, John Morse, has issued a brief to remind us that posting expiration dates of coaches safety certifications and background screens without permission from each coach is a violation of the USA-S Privacy Policy.

BACKGROUND CHECKS: Since Acxiom runs a BGC on each member once a month, the potential exists that a member could pass the BGC initially and several months later it could come back with a flag if the individual is arrested and/or convicted since the initial check. Although the member record in SWIMS will be flagged immediately and the 'valid to' date set to a date in the past, the member will still have a valid USA Swimming membership card. Therefore, please use the lists of Officials and Coaches which I send to all meet hosts and meet referees prior to the meet instead of just allowing members to show their USA_S membership card in order to be on deck at a meet.

Occasionally, it can take up to 6 to 8 weeks for a BG check to clear. In these cases USA Swimming will provide these coaches with a letter allowing them to coach until their background check can be completed and/or cleared. One of these letters could appear at your swim meet and meet directors and meet referees need to know that the letter is legitimate. Please don't jump to conclusions or spread rumors about someone who receives this letter. This letter will be issued only in special circumstances when Acxiom makes USA-S aware that they require additional time to complete the screen--the letter is NOT issued to just anyone who waits until the last minute to initiate their BGC. I will provide details regarding these in future listings of Coaches and Officials.
